## MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding (MoU) is executed on this 1<sup>st</sup> Day of November, 2021 between SKILLFINITY, GUWAHATI, hereinafter, referred as the First Party and C.K.B. College, Teok, Assam referred the Second Party.

Whereas, both the Parties have agreed to collaborate with each other in undertaking joint initiatives aimed at knowledge sharing for the betterment of faculty members and students.

Now whereas, it is agreed between the parties that,

1. The First Party shall assist the second party in undertaking their respective academic developmental activities and the second party would provide the infrastructure facility and related support services, wherever necessary.
2. The first Party shall regularly share the relevant training in mentoring expertise, beyond academic governance in the form of training to teachers and students in the required areas of the college, for fruitful performance of the agreed activities for purely institutional development.
3. Both the Parties may organise short term training programme STTPs under the joint banner of both the Parties.
4. Both Second and First Party shall or may sponsor its faculty/support staff to the training programmes as and when arises, to be trained by the other Party.  
It is to be clearly mentioned that such agreements are purely non-binding.
5. Both the Parties shall organise regular meetings for identifying the areas of specific joint action/collaboration and reviewing the progress of on-going activities of students and teachers.
6. With expertise and experience in the field of research and teaching, the first Party will need to extend its services in terms of training and





placement in close coordination with the college's CCPC, Career Counselling and Placement Cell, on mutually agreed terms and conditions.

It may clearly be noted that the First party may need to provide information, query, grooming, clarifications, procedures of training, tracking records and providing the same to the second party and other pre requisites of the placement avenue.

7. The financial involvement (if any) of any activity shall be mutually decided.
8. The first party may be introduced as a resource to any governing machinery that seeks information for the college's placement avenue. The first party may need to interface, interact and provide information to these bodies, if required.
9. Establishment cost, if any, may be mutually agreed upon for hasslefree functioning of schemes, apart from other financial implications and involvement, if any.

The collaborative activities as per this Memorandum of Understanding shall be governed by the rules and regulations of both the concerned institutions. This agreement will take effect from the date of its signing and shall be valid for a period of 5 years from that date and may be extended by mutual written agreement. However, this MoU may be terminated by either party after giving 30 days' notice of its intention to do so.
